#### **DISCUSSION / PRESENTATION ITEMS:**

IV. US64 Shiprock School Zone Presentation......Larry Joe, Shiprock H.S. Staff & Students

#### BACKGROUND

- Why? Concerns have been raised for the Shiprock School Zone on US64 in Shiprock
- Purpose. There is a growing need to improve and lengthen the school zone corridor in Shiprock along US64, due to the lack of safe pedestrian crossings as well as sidewalks and other needed improvements for a 1.5 – 2 mile stretch along this corridor serving 5 different schools as well as day care facilities.
- Discussion/Finalization. Presentation from Shiprock School staff (and students) will illustrate the issues that are growing concerns for student access to school, along with pedestrian and multimodal safety along this corridor. The NWRTPO will work with NDOT staff during the upcoming cycle to get this project on our next RTIPR.

#### WORK TO DATE:

 Shiprock school staff and students have developed a presentation to showcase the safety and access issues and concerns along this corridor.

#### ANTICIPATED WORK

- RTPO staff will work with NDOT staff to get this project on our FY 18 19 RTIPR.
- Local School and Shiprock Chapter staff will need to collaborate with NDOT staff to get this project in as many other plans as possible: School District development plan, ICIP, Community Comprehensive Plan, Local or Regional Safety Plan, etc.

#### BUDGET IMPACT:

No budget impact to the RTPO; RTPO staff will work with NDOT staff to get this project on our next (FY18 – 19) RTIPR, seeking major funding for significant improvement along this corridor.

#### ACTION ITEM

 No action at this time; future action anticipated for approval of this project for inclusion in the FY18-19 RTIPR.

#### Discussion:

- Several students presented their experience with US64 safety issues and mud
- Students presented a Video on safety and access problems along the Shiprock US64 School Zone which they themselves developed.
- Excellent depiction of safety and mud issues
- Students presented again after presentation and interacted with the RTPO members and DOT staff
- Dist. 5 emphasized that a lighting agreement is all that's holding up improvements to proceed for this corridor
- Marticia Holiday: helpful to see the development along this route justifies further road and safety improvements
- Amber Crotty: lighting agreement has completed 164 process with resolution from RDC
- Joe Sanchez: explained some of the data and process to the students for road / safety improvements
- Steve Lopez: explained the process and cross-jurisdictional complications
- Amber Crotty: can we at least do some safety improvements flashing beacons and such?
- Considerable discussion ensued around alternate funding sources, and the need to get the project in as many local / regional plans as possible
- V. <u>NMDOT Statewide Prioritized Bicycle Network Plan Presentation</u>......Wade Patterson, NMDOT Liaison (Active Trans. Prgms Supervisor / BPE Coordinator)

#### BACKGROUND

- Why? The prioritized statewide Bicycle Network Plan (NM Bike Plan) considers how to best provide New Mexico residents and visitors with a safe and connected bicycle network at the statewide level.
- Purpose. The NM Bike Plan prioritizes corridors and creates design standards by corridor type. These tools will help guide roadway improvements and incorporate bicycle infrastructure on NMDOT roadways as they undergo regularly scheduled maintenance as well as major reconstruction.
- Discussion/Finalization. The NMDOT is beginning a public outreach and involvement process to assure adequate participation from the public and stakeholders, starting with the state's MPO and RTPO network.

#### WORK TO DATE

The initial plan is in development as presented at today's meeting for the NWRTPO.

#### ANTICIPATED WORK

- MPO's and RTPO's will participate in public outreach to help assure that every region of our state has an opportunity to participate in the development of the final plan.
- As the plan is completed, the regional and local work begins with local governments and stakeholders collaborating with the NMDOT for development of a safe, prioritized, and reliable bicycle infrastructure network.

#### Discussion:

- NMDOT's development of a statewide prioritized bicycle plan is supported by Bohannan Huston and ALTA engineering firms.
- The plan seeks to prioritize roadway enhancements around the state for bike paths, leading to safety improvements and economic development opportunities
- This is an improvement plan does not cite projects; but supports future development of projects
- There are 5 schools in this corridor and 1 day care center. They are soliciting public input through meetings and web based outreach.
- RTPO's, MPO's, DOT Districts, bike advisory groups and the BPE Committee are involved.
- There is a questionnaire within the website
- DOT is also interested in local bike plans related to connectivity for this network
- First draft is coming in March, 2018
- Much discussion from members on local (link to the network) options
- Right now just identifying potential routes; thereafter much cross-jurisdictional collaboration for development

#### VI. NWRTPO Regional Work Program Status Report:......Robert Kuipers, NWRTPO Staff

- Why? Due to a NMDOT Office of Inspector General (OIG) Audit and subsequent findings NWRTPO and COG staff met with NMDOT Planning Bureau staff to develop a corrective action plan (CAP).
- **Purpose.** As part of our CAP RTPO staff will provide monthly reports showing line item budget expenditures and staff hours in comparison with the approved Regional Work Program (RWP) Budget.
- **Discussion/Finalization.** Based on this monthly analysis and report, staff will better manage time and funding investment, and assess where and when to seek a RWP amendment if needed.

#### CURRENT WORK

- RTPO staff met with NMDOT staff on 12/7/16 to review a draft corrective action plan, detailing specific actions
  and controls in a number of areas to assure stronger compliance to the RWP budgeted time and financial
  allocations.
- The Corrective Action Plan has been finalized and is now being executed.
- RTPO Staff have provided reports at monthly meetings: January March 2017
- In quarter 2, RTPO staff submitted Amendment #1 to modify our hours per function and annual RTPO FFY17 budget, as approved by the RTPO Committee (February 2017).

#### ANTICIPATED WORK

- Ongoing reports to the NWRTPO members at monthly meetings.
- RWP amendment requests may be anticipated, as time and budget demands may vary as the fiscal year progresses.
- Our annual Quality Assurance Review (QAR) occurred on April 12, which provided a good check-up on how the RTPO is performing.

#### **BACKGROUND**

- Why? While NWRTPO members have a lot of focus on multi-modal surface transportation development, another transportation element that the RTPO supports and serves is aviation. 

**Why?** Due to a NMDOT Office of Inspector General (OIG) Audit and subsequent findings, NWRTPO staff met with NMDOT Planning Bureau staff to develop a corrective action plan (CAP).

**Purpose.** As part of our CAP RTPO staff will provide monthly reports showing line item budget expenditures and staff hours in comparison with the approved Regional Work Program (RWP) Budget.

**Discussion/Finalization.** Based on this monthly analysis and report, staff will better manage time and funding investment, and assess where and when to seek a RWP amendment if needed.

#### WORK TO DATE

- RTPO staff met with NMDOT staff on 12/7/16 to review a draft corrective action plan, detailing specific actions and controls in a number of areas to assure stronger compliance to the RWP budgeted time and financial allocations.
- The Corrective Action Plan has been finalized and is now being executed.
- RTPO staff have provided reports at monthly meetings: January November 2017
- In Quarter 2, RTPO staff submitted Amendment #1 to modify our hours per function and annual RTPO FFY17 budget, as approved by the RTPO Committee (February 2017). A copy of the FHWA/NMDOT approval of this amendment was attached. RTPO staff are preparing to submit amendment #2 for our biennial work program approved at our August RTPO meeting, adjusting hours based on our experience and expectations to the NMDOT Planning Dept.

#### **ANTICIPATED WORK**

- Ongoing reports to the NWRTPO members at monthly meetings.
- RWP amendment requests may be anticipated, as time and budget demands may vary as the fiscal year progresses.
- Our annual Quality Assurance Review (QAR) occurred on April 12<sup>th</sup>, which provided a good check-up on how the RTPO is performing.

- A. NWRTPO Regional Work Program and Budget Update: During our August meeting, RTPO staff presented updates to our FFY 18 Regional Work Program and budget, which primarily consist of changing time allocations to the various work function components, based on our experience this past year, and anticipated time investment needs for the upcoming year. RTPO members approved and authorized this second amendment to the NWRTPO RWP for FFY 18. RTPO staff will be submitting this amendment to the NMDOT Planning Dept. for approval for the FFY 18 work program during the course of this first FY18 quarter.
- B. 4 Corners Counties Collaborative Meetings: RTPO staff continue to support ongoing meetings sponsored by McKinley County, that include all interested / participating counties within Arizona, New Mexico, and Utah, that are part of Navajo Nation lands, along with BIA and Navajo Nation representatives. This group continues to seek ways to find more cost and time efficient transportation development and maintenance through cross-jurisdictional agreements.
- C. GIS Data Gathering, Mapping and Compiling Work: RTPO staff will continue to reach out to our three Pueblos Laguna, Acoma and Zuni regarding the opportunity to include their transportation mapping and data into our regional portfolio, based on what each Pueblo is willing to share. COG staff continued GIS mapping for new development of 36 miles of recreational trails in the Zuni Mountains McKinley County area during October.
- D. 2018 NMDOT Rail Plan Update: RTPO staff continue reaching out to our members to take advantage of a window of time this year to include our local govt. interests in the NMDOT Rail Plan update, by simply informing the DOT Rail staff of (near future) local rail opportunities that may have potential for plan inclusion.



The Oregon Department of Transportation released a final report, Green Infrastructure Tor Resilience of the Oregon Coast Highway, documenting the results of a FHWA sponsor project. Oregon DOT developed conceptual designs for three locations along coastal high 101 vulnerable to storms and coastal bluff erosion. These designs include cobble beache artificial dunes, sand tubes, mechanically stabilized earth, riprap, and planted terraces. # FHWA Publishes Summary of Resilience and Transportation Planning and Project Development Peer Exchange

To objective of the meeting was to foster a meaningful exchange of ideas among practitione Region 5 States, focused on issues and approaches for addressing greenhouse gas (Ghemissions analysis and resilience in transportation planning and the project development In general, peers agreed that a detailed GHG emissions analysis as part of the NEPA probe useful for disclosure but likely would not add much value to decision making due to the relatively small differences in emissions between alternatives. The group also discussed to assess vulnerabilities and plan for resilience, including the potentially increased consiculmate change and extreme weather events in NEPA Purpose and Need statements. # Photovoltaic Noise Barriers Report Summarizes the Opportunity and Potential for Producing Noise Barriers on Highways

A recent FHWA report summarizes current practices in photovoltaic noise barriers (PVNI globally and discusses the potential benefits of PVNBs in place of, or in addition to, exist barriers. PVNBs represent the combination of noise barrier systems and photovoltaic sys mitigate traffic noise while simultaneously producing renewable energy using photovoltai installations. First deployed in Switzerland in 1989, PVNBs are now found in several courant transportation agencies have sought ways to find multiple uses of their infrastruct. PVNB experience documented in the literature and supplemented through a series of interprovides evidence suggesting that noise barriers can be designed to produce renewable without compromising their abilities to reduce noise, and do so safely. Given the substant of noise barriers in the country, the potential for solar energy production on American noi barriers is likely at least 400 Gigawatt hours annually, roughly equivalent to the annual eluse of 37,000 homes, and perhaps much higher.



Proposed Guidelines for Funding Awards beginning FFY20

Who May Apply? The CMAQ program will be open to Tribal/Local Public Agencies (T/LPAs) as well as transit providers (or other public transportation agency) and NMDOT District Offices.

**How Much is Available?** The estimated annual funding available for applicants beginning in FFY20 is \$8,651,000 (federal). The final targets for FFY20 have not been issued yet.

How do I Apply for Funding? Applications for projects beginning in FFY20 will be opened in the spring of 2018 with final applications due in November 2018. The process will be concurrent the TAP/RTP application timeline and will follow a similar protocol. 


