

Getting to Know the Lay of the Land


The three-county region of northwest New Mexico comprises approximately 15,500 square miles of rich cultural, natural, and ethnic diversity. Within this tri-county area are six municipalities (Grants and Village of Milan in Cibola County, Gallup in McKinley County, and Farmington, Bloomfield, and Aztec in San Juan County), five Indian reservations, and two Land Grants. There are 69 rural, unincorporated communities, the majority of which are tribal communities.




Map 1: State of New Mexico




Map 2: Map of Northwest New Mexico





Land ownership is depicted in the graphs and map on this page. The majority of the lands in the tri-county region are nontaxable tribal trust, federal, and/or state lands. A good majority of these federal lands are reservation; however, other federal lands include Bureau of Land Management (BLM) lands throughout eastern areas of San Juan and central Cibola Counties. U.S. Forest Service land can be found in both Cibola and McKinley Counties (Cibola National Forests).



About half of the land area in the region is administered as American Indian Reservations (see reservations map). Sovereign tribal territories of the Navajo Nation within the region include 53 of the Nation's 110 geopolitical units, or Chapters. These Chapters are concentrated largely in San Juan and McKinley Counties. A small portion of the Mountain reservation extends into San Juan County. The Pueblos of Zuni (in McKinley and Acoma County) and Laguna in (Cibola County) are some of the oldest human settlements on the continent.

By treaty, the Navajo Nation and the Pueblos have been recognized as quasi-sovereign tribal governments, while their tribal members have dual US citizenship under county and state political structures.

In 2004, the New Mexico State Legislature

established local government status for the State's Land Grant communities, recognizing La Merced del Pueblo de Cebolleta and Santa Rosa de Cubero Land Grants in Cibola County as selfgoverning political subdivisions of the state.

Climate



Northwest New Mexico's climate is just as varied and diverse as its rich culture, people, and history. Terrain across the three-county region ranges from mountains, canyons, and high mesa plateaus. Sunshine is abundant, as is typical of New Mexico and of late, drought has been more common from year to year.

The annual average temperature in the region is about 67° F. July is the warmest month, typically, and temperatures in low valley areas can exceed 100° F. January

is the coldest with average temperatures around $15^{\circ}F$ (see Table 3).

Precipitation in the region varies greatly with much the result of winter snowfall and infrequent but intense and heavy summer thunderstorms. The region can vary with precipitation as noted in the chart below.

Snowfall in the region can begin around October through April or May in some areas with averages between 10 inches and more than 30 inches in higher mountain areas.

Spring winds increase in the months of March through May. The eastern parts of the region experience greater wind speeds which can peak at 50 mph or more. Table 2 below shows the average wind speeds at reporting airports with automated stations monitoring hourly wind speed data.


The People of Northwest New Mexico

Population

The Northwest New Mexico three-county region has a combined population of 228,749 people or approximately 15 persons per square mile (6 persons per square mile in Cibola, 13 persons per square mile in McKinley, and 24 persons per square mile in San Juan) according to the last Decennial Census conducted in 2010. The figures below show the total populations for each county (Cibola, McKinley, and San Juan) and the cities of Aztec, Bloomfield, Farmington, Gallup, and Grants and the Village of Milan. Table 4 lists 69 rural, unincorporated communities' total population counts throughout the region.

In Cibola County, the median age is 36.6 years (males have a median age of 36.0 years and females, 37.3 years) based on

the 2010 Census. Sixty-one percent of the population is between the ages of 20 and 64 with 12% younger than the age of 19 and 27% above retirement age of 65. McKinley County has a median age of 30.7 years (the median age for males and females in McKinley County is 29.2 years and 32.4 years, respectively). The majority of residents, 55%, in McKinley County are between the ages of 20-64 with 35% younger than 19 years old and only 10% older than 65. Lastly, in San Juan County, the median age is 33.0 years old (males: 32.1 years and females: 34.0 years old). Thirty-two percent of the population in San Juan County is below the age of 19, 57% between age 20 and 64, and only 11% over the age of 65. Table 9 shows the median ages of the three county populations

Historic Population Trends




Figure 2: Historic Population Trends

Overall, population growth for the Region has been relatively flat, since 2000, with a slowing growth rate of 0.7% from 2000 through 2010. More than half of the population in the Region is in San Juan County, which has gained a 14.3% change in population over the past 10 years with a 1.3% positive growth rate. McKinley County is the second most populous county in the region and has experienced a decrease in

population with a negative 4.4% change in population and a decreased -0.5% growth rate since 2000. Cibola County is home to approximately 27,000 people and has been growing, albeit at a slower rate than the Region. Cibola experienced а 6.3% change in population from 2000 to 2010 and a growth rate of 0.6% in the past decade. A historical growth in the Region is demonstrated in Table 5 and Figure 2.

The City of Farmington is currently the most populous municipality in the region, with more than 45,000 people calling Farmington home. The City of Gallup, one of the oldest incorporated cities in the region, has a population less than half that of Farmington with just under 22,000 residents. The third most populous

city in the region is the City of Grants with just over 9,000 people. Two of the three current most populous cities in the region also serve as the County seats for each of their respective counties (Gallup in McKinley and Grants in Cibola); however, the City of Aztec is the county seat in San Juan County.




Figure 4: Historic Population Trends








Figure 5: Age Groups Charts Counties & Municipalities




Figure 6: Total Population by Race (Percentage) by County




Figure 7: Employment in the Region 2001-2011

Distance to Work

A good majority of residents benefit from a short commute from home to work in all three counties. In Cibola County 45% of workers, McKinley County 57% of workers, and in San Juan County approximately 55% of workers commute less than 10 miles from home to work.

Twenty-one percent for Cibola, 12% for McKinley, and 25% of workers for San Juan are traveling between 10-50 miles. Approximately, 33% of workers in Cibola County, 30% in McKinley County, and 21% of workers in San Juan County travel more than 50 miles to work.




Figure 8: Unemployment by County




Figure 9: Unemployment Rate (%) by County




Figure 10: Civilian Labor Force by County




Figure 11: Jobs by Worker Educational Attainment in Cibola County




Figure 12: Jobs by Worker Educational Attainment in McKinley County




Figure 13: Jobs by Worker Educational Attainment in San Juan County

Income

As of the 2010, San Juan County was ranked 5th highest out of 33 New Mexico counties with Annual Average Wage/Salary per Job. Cibola County is ranked 12th highest and McKinley County is ranked 17th highest in New Mexico.

Per Capita Personal Income is significantly different for the three counties. Again, San Juan County has the highest standing of the three counties in the northwest New Mexico region; San Juan County ranks

21st out of 33 New Mexico counties, as of 2010. Cibola County ranks 30th and McKinley County ranks the lowest of all New Mexico counties at a ranking of 33rd. According the U.S. Department of Commerce's Bureau of Economic Analysis, McKinley County's average annual growth rate of Per Capita Personal Income (PCPI) was 5.7% from 2001-2010. For Cibola County the PCPI average annual growth rate was 5.2% and for San Juan County, it is 4.4%.




Figure 14: Annual Average Wage by County




Figure 15: Per Capita Personal Income




Figure 17: Cibola County Private Sector Employment and Average Weekly Wages




Figure 18: McKinley County Private Sector Employment and Average Weekly Wages




Figure 19: San Juan County Private Sector Employment & Average Weekly Wages

The Economy



In 2008 the northwest New Mexico region generated nearly \$12 billion in gross receipts, with San Juan County leading the region in gross receipts (see Table 34 on page 41). However, in 2009, gross receipts dropped to just under \$9.5 billion or by approximately 20%. By 2010, this regional total increased to a little over \$10 billion. The municipalities of Aztec, Bloomfield, Farmington, Gallup, Grants, and Village of Milan generated \$5.8 billion in gross receipts all together in 2010 with Farmington, Aztec, and Bloomfield cities bringing in a bulk of the gross receipts at \$4.1 billion, Gallup at nearly \$1.3 billion, and grants and the Village of

Milan bringing in just over \$418 million.

In the following tables and charts you will see that Retail Trade is a major source of gross receipts in each county and in some of the regional municipalities. Other industry sectors such as Mining and Oil and Gas Extraction. Wholesale Trade. Construction, or Health Care and Social Services also play major roles in gross receipts in the region.




Figure 20: Gross Receipts Totals by County




Figure 21: Gross Receipts Totals by Municipality

Transportation

Highways

The region's transportation network includes a major east-west interstate highway, Interstate 40, which spans nearly the entire country with the eastern terminus in Wilmington, North Carolina and the western terminus in Barstow, California. Several important north-south highways (US 491, NM 371, and NM 602) and east-west highways (NM 53, US 64 and US 550) extend across the region connecting northwest New Mexico's major towns and cities with larger New Mexico cities such as Albuquerque, Santa Fe and both states of Colorado and Arizona. Additionally, Historic Route 66 runs east-west through Grants and Gallup.

There is also a vast network of county and rural roads (some paved and many unpaved) crisscrossing the northwest New Mexico region. The map to the right illustrates the major roads and highways in the northwest New Mexico region.

Rail



The Burlington Northern Santa Fe (BNSF) Railway line runs directly through McKinley and Cibola Counties. Daily, the BNSF transports products and raw materials across its vast network of railway lines. Amtrak, the national rail passenger service runs on the BNSF railways with stops in Gallup and Grants.

Bus and Transit

The region has several transit and bus lines which connect riders in key locations throughout the region.

The cities of Farmington and Gallup offer municipal public transportation. In Farmington, the Red Apple Transit, which also extends routes to the cities of Aztec, Bloomfield, and community of Kirtland, moves riders in and throughout the City of Farminaton. The Cibola Transit Authority, of which the Village of Milan is the fiscal agent, is comprised by Milan, Grants, and Cibola County -- offering service within the two municipalities and some unincorporated areas in County. Lastly, Gallup Express operates within the City of Gallup.

On a regional scale, Navajo Transit System offers riders routes throughout the Navajo Nation (extending into Arizona and Utah) but also in the northwest New Mexico region from Gallup, Shiprock, Crownpoint, and various points in between. In the Pueblo of Zuni, ZEE, Inc., Public Transportation Program offers services in and around the Pueblo of Zuni and surrounding reservation communities (Black Rock) as well as services into Gallup, New Mexico. Lastly, recent agreements between the Pueblo of Laguna's Shâa'skr'a Transit and the City of Albuquerque's ABQ Ride offer transit services between the Pueblo and Albuquerque, New Mexico also.

The chart below demonstrates the trend for ridership on some of these public transportation programs. Table 33 provides specific numbers.




Figure 22: Public Transit Services Ridership Counts

Air

The Four Corners Regional Airport (Airport Code: FMN) in Farmington (owned by the City) is the largest airport in the region. Air services include direct flights to several major western cities: Denver, Las Vegas, Phoenix. and Ontario/Los Angeles. Destinations to multiple smaller Arizona cities such as Page, Prescott, Show Low, and Kingman, Arizona and Merced, California are possible as well. Figure 20 shows the passenger counts over the past 10 years. Additionally, the Four Corners Regional Airport receives cargo flights from Federal Express (FedEx), United Parcel Service (UPS), and the instate carrier Distribution Management Corporation (DMC).

Other smaller airports in the region include the City of Gallup Municipal airport (GUP), the Grants-Milan Municipal airport (GNT), and Black Rock airport (ZUN) in Zuni, New



Mexico. These airports are publicly owned, either by the municipality or tribal government and are aeneral aviation airports including aviation operations and air taxi services. Gallup airport services Municipal include Federal Express (FedEx) and Gallup Med Flight medical transport services. The small map on the next page shows the location of these airports





Figure 23: Four Corners Regional Airport Passenger Traffic




Figure 24: Educational Attainment by County






Figure 25: Public School Total Enrollment


Post-Secondary Education
