New Mexico DOT Statewide Transportation Improvement Plan (STIP)	NMDOT	2020	Five-year STIPs detail transportation capital projects that are programmed federal, state, or local funding in that period.
New Mexico Highway Safety Improvement Program (HSIP) Targets	NMDOT	2020	Annual report that documents progress towards targets defined in the state's Strategic Highway Safety Plan and other planning efforts and progress updates of programs under the HSIP. Key takeways from the 2020 report include an increase in fatal crashes on state interstates in the period 2015-2019.
Freight-Related Economic Development Opportunity Study	NMDOT	2016	This study examines economic development opportunities for New Mexico communities located in key truck freight corridors, given recent regulatory and other changes in the trucking industry. The study finds that communities such as Gallup and Lordsburg are well positioned to take advantage of new federal rules that require truck drivers to rest after 14 hours of driving.
New Mexico Strategic Highway Safety Plan	NMDOT	2016	The SHSP is the overarching transportation safety plan for New Mexico. The plan establishes a vision of "Safe Mobility for Everyone," with a primary goal of

			reducing fatalities and serious injuries for all users on New Mexico roadways. The SHSP identifies 10 High-Priority Focus Areas, including distracted and impaired driving, based on how often the Focus Area contributes to fatal and serious injury crashes.
New Mexico Freight Plan	NMDOT	2015	The New Mexico Freight Plan is an analysis of road and rail freight that are working well or need attention. Truck vehicle miles traveled are growing at a fast pace along freight corridors in the northwest and southeast region of New Mexico.
The New Mexico 2040 Plan (Statewide LRTP)	NMDOT	2015	The plan is the state's long-range transportation plan, which identifies the goals/objectives/priorities of the state's transportation networks for the year 2040 and lists an inventory of the state's current transportation assets.
New Mexico Statewide Rail Plan	NMDOT	2014	This plan includes an inventory and details the vision/goals/objectives for the state's passenger and freight rail networks. The plan is required for federal funding for rail projects.
New Mexico Intelligent Transportation Systems (ITS) Program	NMDOT	Ongoing	This program operates the state's ITS infrastructure, which uses advanced technology to improve safety and mobility along roadways and other transportation infrastructure. ITS is what operates electronic messaging signs along Interstate 40 that provide traffic and weather alerts to motorists. ITS also allows real-time roadway conditions to the NMDOT and law enforcement.
New Mexico Scenic Byways Program	NMDOT	Ongoing	The program directs resources towards maintaining 26 highway routes throughout the state that have notable scenic, cultural, and historic characteristics. The Trail of the Ancients route extends through the Prewitt-Milan TMP project area.
New Mexico Rest Areas	NMDOT	Ongoing	The state is considering funding to upgrade rest stops along the state's interstates and highways. No formal planning effort for this has begun.

A Regional Economic Assessment & Strategy for Coal- Effected Communities	NWNMCOG	2017	This document was created to address changes in the local economy due to disinvestment in the Four Corners region's mining and energy production sectors. The report identifies several key strategies to improve the regional economy, including workforce and business development, quality of life investments meant to retain talent and attract employers, and partnerships to improve branding and marketing of the local economy and communities.
Stronger Economies Together (SET) Plan, Trail of the Ancients Region	USDA Rural Development/NMSU Cooperative Extension/NWNMCOG	2015	This is a regional economic development plan for rural areas of San Juan, McKinley, and Cibola counties. Four key areas of economic growth potential are described: 1) Agriculture and food systems, 2) Tourism and artisan enterprises, 3) Manufacturing, and 4) Workforce development and entrepreneurship.

Comprehensive Plan for Cibola County, New Mexico	Cibola County	2015	The Comprehensive Plan for Cibola County contains strategies and objectives regarding the improvement and growth of the county by addressing issues related to land, natural resource management, development, infrastructure needs, and several other issues.
McKinley County Comprehensive Plan	McKinley County	2012	The comprehensive plan for McKinley County. Among the elements of the plan's vision include: "Quality jobs," "New investment in this region," and "Diverse economic development strategies." The plan notes the good location of county at the intersection of major transportation routes, but it raises the challenge presented by low population density to meeting the community's mobility needs.

Northside Infrastructure Plan	Village of Milan	2009	This plan identified infrastructure needs, especially water, wastewater, and drainage, on the north side of the Village of Milan, including the future site of the Milan Industrial Park.
