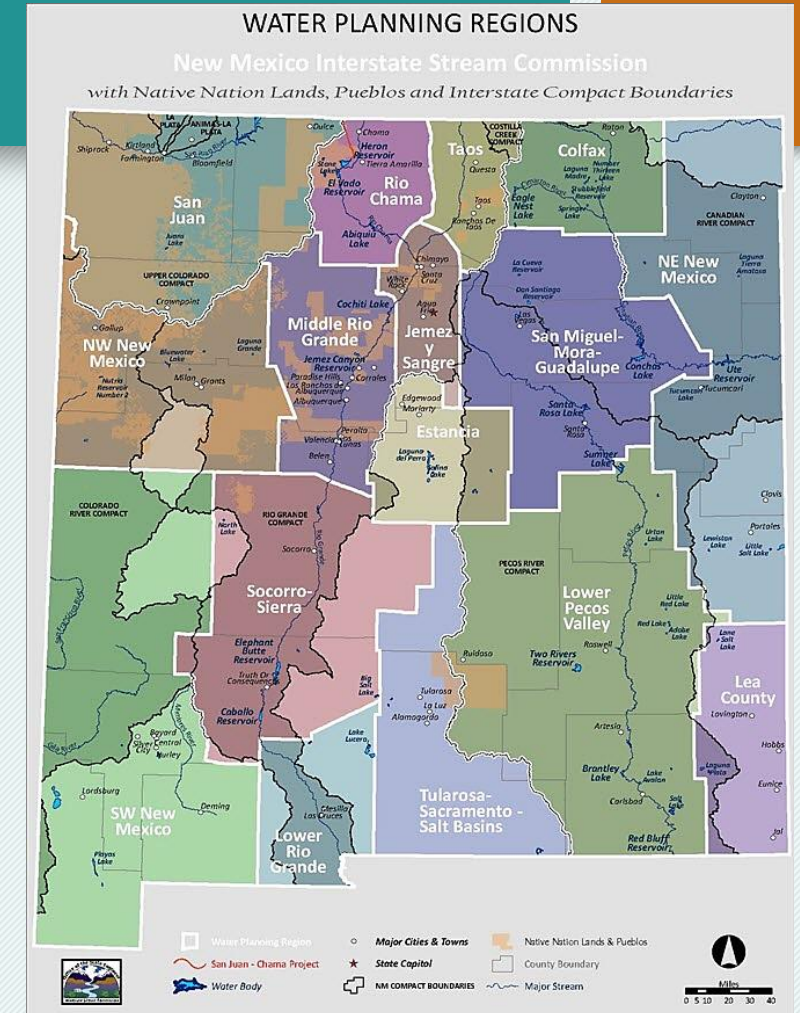

1. **Welcome.** Angelina Grey, COG Planner, opened the meeting at 9:00AM and reminded attendees that the meeting is being recorded for future references. Meeting officially started at 9:08am due to presenter having technical issues with logging on. Thank attendees for participating. Introduced presenter that was scheduled to present at the last meeting but will little attendance, it had to be rescheduled to December. A copy of this presentation included in the agenda packet for this meeting.
2. **Presentation: Regional Water Planning.** Bob Wessely, Middle Rio Grande Water Advocates, is today's guest presenter.
 - Mr. Wessely's presentation will focus on:
 - current activities with the organization,
 - provide updates on regional water planning for the Middle Rio Grande region,
 - crucial nature of updating the state water plan and the respective regional water plans. Currently in progress.
 - The Middle Rio Grande Water Advocates is a local work group for the Sandoval, Bernalillo and Valencia Counties; has been involved in regional water planning since 2000; assisted with updating regional water plans for the Middle Rio Grande region and the Mora-San Miguel region.

Timeline:

- 2013 – Regional Water Planning updated, addressed issues concerning the water planning processes; led to creating the 2016 Water Planning study group of regional planners (representing 14 of 16 districts); developed water planning issue papers; Larry Winn and Jeff Kiely participated in this activity.
- 2017 – House Memorial 1 – request for water planning legislation; telling legislators what is needed in regional water planning come 2019; update of the regional water plan developed; “Making the Case for Change” publication released.
- 2019 – Senate and House Bills – statutory needs for water governance; 3 bills total in response to HM1.
- 2020 – Governor’s campaign proposal to develop the 50-Year Water Plan; came to fruition in 2021.
- Discuss on how we should proceed; need to understand the physical climate impacts over the next 50 years, not what we should do about it but more about what will happen.
- NM Tech research team conducted study, developed presentation materials and final report; presented to state; stressed on resiliency and gathering recommendations on potential solutions; next public meeting in January 2022, state to collect and compile data and develop plan by March 2022.

Proposing a framework for water planning and what that might look like:

- Planning has discontinued due to lack of funding; the ‘stepchild’ in the state’s eyes; water advocates are working with the Interstate Stream Commission (ISC) in updating the planning paradigm; potential to incorporate into the state water plan; work as a guidance for legislators to gain support and funding.
- Proposing that the state adopt this framework:
 - i. *Be a recommendation in the Fifty-Year Water Plan,*
 - ii. *Provide Guidance for Legislative Bills; inform legislators the importance of water planning,*
 - iii. *Serve as Justification for Serious Funding Action.*
- Content of the framework:
 - *Present the Purposes of Water Planning,*
 - *Explain the Benefits to Funders,*
 - *Address the Establishment of Water Planning Capacity,*
 - *Provide an Inventory of Possible Planning Components.*
 - Planning should be an ongoing and continuous process. Focus on identifying problems and develop solutions. Ensure implementation is an on-the-ground action. Do not shelve the plan.
- Bottom-up approach to planning:
 - *Planning Is an Ongoing, Iterative Process,*
 - *Intended to Identify Problems and Develop Solutions,*
 - *Planning Must Lead to On-the-Ground Action,*
 - *Encourage/Support Self-Defined Community Planning Entities within Regions,*
 - *It’s the Communities that Have the Knowledge and Skills,*
 - *Goal Is to Identify/Solve Problems at the Appropriate Level.*
- Regional coordination and planning structure:
 - *Regional Entities Coordinate the Communities Planning,*
 - *Do the Planning When/Where Community Entities Don’t Arise,*

- *Establish Hydrologically Defined Planning Regions,*
 - *Ensure Regional Planning Entities Are Ongoing,*
 - *The Regions Coordinate and Aggregate Contained Communities' Planning,*
 - *Identify and Address Region-Wide Problems,*
 - *Coordinate with Adjacent Regions' Planning.*
- Encouraging planning communities in regions; these planners know what the issues are locally; broader context can be expanded across regions, resulting in 'regional water planning.'
- Regional entities coordinating community planning to identify local issues.
- Examples of possible hydrologic regions. Potential for redistricting water regions throughout the state and what that might look like.
 - Involve looking at hydrologic regions to define each region instead of political boundaries (pink lines).
 - 3 proposed water regional maps show how much hydrologic regions are meaningfully different from political districts.
 - Regional offices that focus on regional issues; legislative funding supporting each region, funding gets trickled down to local projects.
- Proposed framework for water planning:
 - *State Planning Entity Obtains and Distributes Funding for Water Planning,*
 - *State Planning Entity Oversees Planning Activities,*
 - *Coordinates and Supports the Regional Planning Efforts,*
 - *Identifies and Solves Problems of a Statewide Nature,*
 - *Verifies Inter-Region Coordination of Planning,*
 - *Approves and Commits to Supporting Approved Regional Plans,*
 - *Coordinates Planning with Other State Agencies.*
- Planning support and accountability processes:
 - i. *Funding and Technical Support – from State to Region to Community,*
 - ii. *Accountability Reporting – from Community to Region to State,*
 - iii. *Regions Verify Inter-Community Coordination,*
 - iv. *State Verifies Inter-Region Coordination,*
 - v. *State Provides Funding of Regional Plan Actions,*
 - vi. *Regional Entities Provide Funding of Community Planned Actions,*
 - vii. *Each Planning Entity Verifies or Ensures Implementation and Monitoring.*
 - Regional planners are responsible and accountable for reporting back to their communities.
- Recommended planning components:
 - i. *Identify Problems to Be Addressed,*
 - ii. *Identify Adaptation Strategy Alternatives,*
 - iii. *Evaluate the Alternatives,*
 - iv. *Develop Recommendations,*
 - v. *Implement the Recommendations,*
 - vi. *Monitor the Implementation,*
 - vii. *Ensure Adequate Follow-On Planning.*
 - Checklist for planners, focusing on local issues and solutions.
 - Identify community-specific issues and concerns.
 - How practical is it? What are the social consequences?
 - What will it cost?

- Comments/Questions:
 - i. Blanca Surgeon: Is the MRGWA a nonprofit and does it represent all the different regions in the state?
 - 501c3 nonprofit, focusing on the:
 - Rio Grand River region but have also addressed statewide issues that have affected local, regional communities, particularly on the agricultural communities and urban growth and demand.
 - Local “miopic” planning vs. statewide/regional planning.
 - Interagency and interregional planning
 - How do you change something that’s been in place for so long?
 - Challenges is developing framework; ISC seem to be interested in the planning paradigm and may be included in some context within the state water plan.
 - Concept of using hydrological boundaries makes sense.
 - Planning starts at the bottom, not the top. Communities are ones doing the planning. Important to push these proposals.
 - Rural communities are often managed by volunteers. Some struggling to fill these positions.
 - ii. Mike Daly comment: Need technical support in this arena, perhaps the county-level, establish a water board that can represent each group.
 - Possible with stakeholder entities to coordinate with communities, assist with financial capacities with funding requirements.
 - iii. Paul Spencer: Will this be a permanent thing for regionalization?
 - Sounds good especially when money funnels down.
 - Do communities need to hire some fulltime to do this? Depending on communities and regions. Could be possible if communities need the help. Concern mostly with aging communities.
 - Gain support from legislators. Define regions. Determine how planning will impact communities. Idea would be to ensure continuity as so regional entities do not dissolve.
 - Will all this effort also help NMED restaff with professionals that communities need? Staffing shortages hold communities back. This has been discussed and will continue to discuss, particularly finding ways to fund regions.

3. Updates from Water Systems:

- MDaly: White Cliffs MDWUA, Gamero WSD and Yahtahey WSD have agreed on sign the JPA; Dominique Cartron (Cartron Law) completed the draft. White Cliffs officially signed the JPA at its formal meeting yesterday, Tuesday, December 14, 2021. Finally coming to fruition after almost two decades.

4. **COG Updates:**

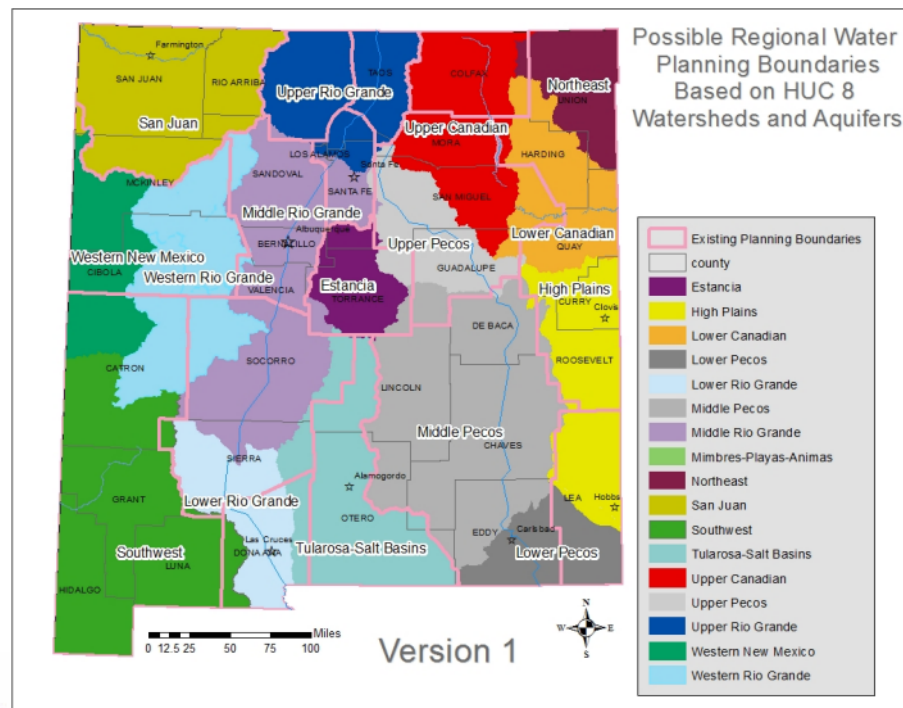

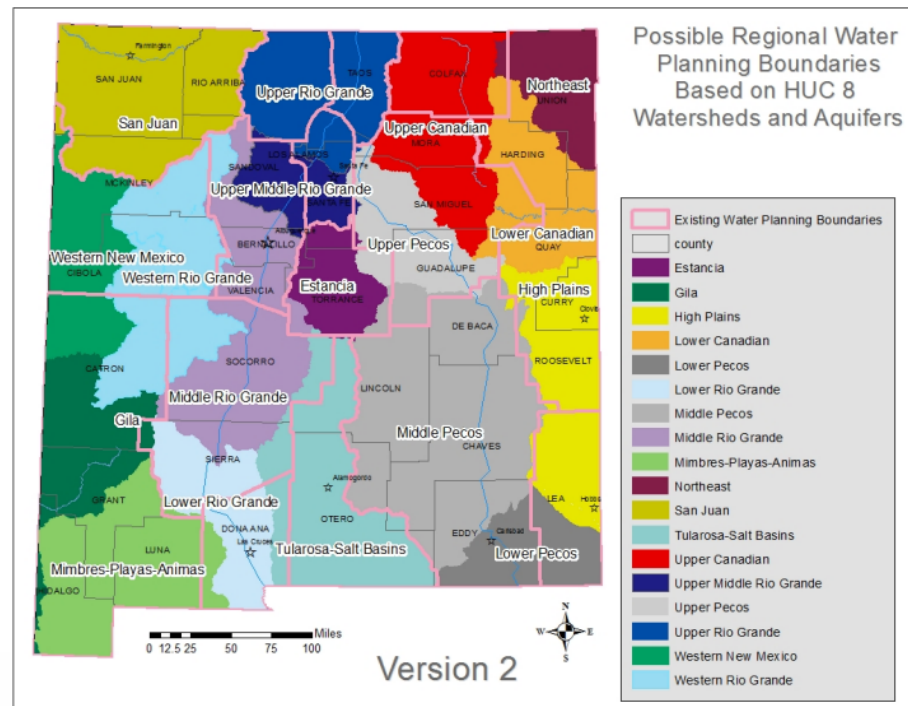

Examples of Possible Hydrologic Regions



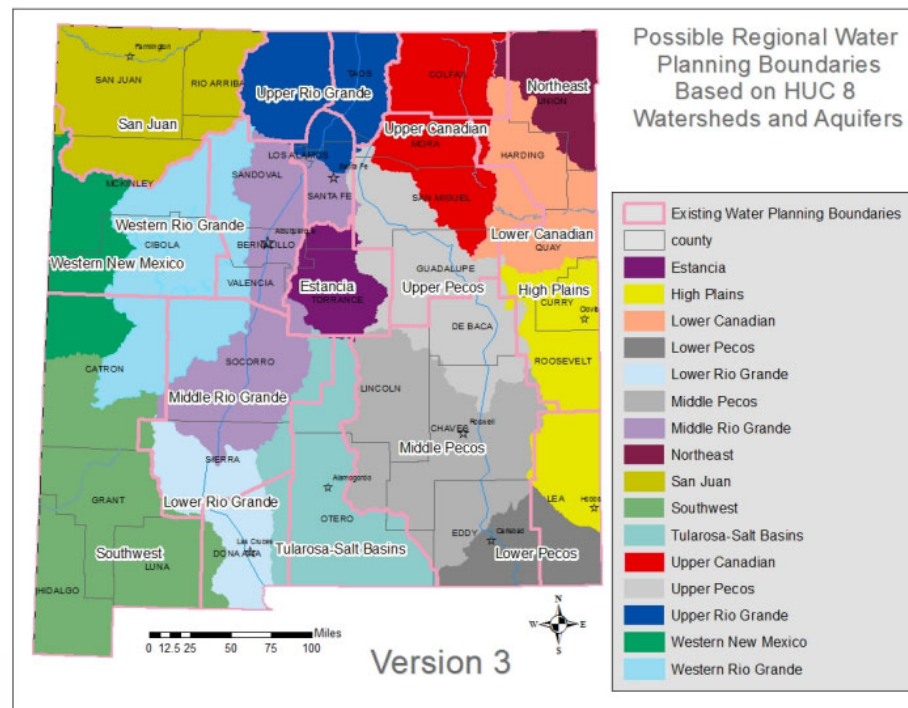

December 15, 2021

1. **November 17th meeting** was not largely attended by small water systems.
 - Meeting and presentation rescheduled to Wednesday, December 15, 2021.
 - Guest presenter, Bob Wessely from the Middle Rio Grande Water Advocates.
 - Proposed planning paradigm for the upcoming 50-Year New Mexico State Water Plan, currently under development by the NM Interstate Stream Commission.
 - Listed key strategies for local governments and regional entities to consider.
For specific recommendations, refer to meeting minutes above.
 - Proposed framework would be modeled to help local and regional planners with community outreach and to gain support from local communities;
 - Framework would function as a guidance for state legislators and perhaps help attract more support and funding for local projects.
